PROGRAM: To date the MDAF has sponsored MOMOMs in



Springfield (2011), Cape Girardeau (2013), St Louis (2014), Columbia (2015), Independence (2016), Joplin (2017) and plans to hold its seventh clinic in Kirksville in 2018. ▪ Awards **DENTAL SCHOLARSHIPS TO MISSOURI STUDENTS**. Since 1999, more than 78 scholarships totaling more than \$216,000 have been awarded.

▪ Offers **FINANCIAL SUPPORT THROUGH A GRANT PROGRAM FOR GROUPS THAT CREATE BETTER ORAL HEALTH FOR MISSOURIANS** through educational programs, access-to-care initiatives and community collaborations. Since this program's recent inception in 2012, the MDAF has awarded 22 grants.

▪ **DONATES DENTAL HEALTH SUPPLIES AND EDUCATIONAL BROCHURES** (including MDA's Stop the Pop and Start Right brochures) to groups or programs that are working to create better oral health among Missourians, with special concentration on groups that provide items to the low-income or underserved population.



▪ Offers member dentists tools to **AID IN VISITS TO SCHOOLS OR HEALTH FAIRS** concentrating on improving oral health.

▪ **MANAGES A \$100,000 ENDOWMENT** – of which \$25,000 will be designated for children's dental health – with a goal to add 10% of each year's income to this endowment.
