



## **Foreign National Attestation**

As of August 28, 2025, the Missouri Ethics Commission requires a Foreign National attestation from all PAC contributors. As a PAC contributor, the MDA is required to collect this attestation from you. Please complete the form below so we have your attestation on file. Prohibited sources are as follows, per § 130.170(3), RSMo - Foreign national: Any of the following:

- An individual who is not a citizen or lawful permanent resident of the United States;
- A government, or subdivision, of a foreign country or municipality thereof;
- A foreign political party;
- Any entity, such as a partnership, association, corporation, organization, or other combination of persons, that is organized under the laws of, or has its principal place of business in, a foreign country; or
- Any entity organized pursuant to the laws of the United States or any state there thereof that is wholly or majority owned by a person or entity described above, unless:

§ Any contribution or expenditure it makes derives entirely from the funds generated by the entity's United States operations; and

§ All decisions concerning the contribution or expenditure are made by individuals who are United States citizens or lawful permanent residents, except for setting overall budget amounts.

§ 130.170(6), RSMo – Prohibited sources: contributions from or expenditures by a foreign national made with the intent to use such funds to influence an election on a ballot measure.
