## Missouri RDH Programs

- In Missouri, there are currently six RDH programs that can graduate approximately 140 RDH per year.
  - Annual variation due to some programs having different graduation dates and alternating enrollments
  - Some students have 18-month programs, so it is difficult to assess the numbers per year.

## Missouri RDH Programs - Current

- Missouri Southern State University, Joplin: 30 students
- Ozark Technical College, Springfield: 20 students
- University of Missouri-Kansas City, Kansas City: 30 students
- ▶ St. Louis Community College, Forest Park: 32 students
  - 2021: Took 16 students due to late graduation date for second year class due to COVID-19
- State Fair Community College, Sedalia: 10 students
  - Every other year it is 12 students
- Concorde Career College, Kansas City: 24 students (graduate every 18 months)
  - This includes at least 25 potential students who graduate in the interim six-month period in an 18-month program

# Missouri RDH Programs - Closed

- ▶ Due to recent closures, approximately 60 fewer RDH graduates per year.
  - Missouri College, St. Louis: Closed September 2016 (30 students every 18 months)
  - Rolla & Sikeston Distance Ed Sites (MSSU, Joplin):
     Closed 2018 (20 students through both sites)
  - Hillyard Technical College, St. Joseph (NCMC, Trenton): Closed Spring 2020 (10 students)






# Summary of Survey Findings

- ► About one third of dentists (35.8%) reported having retained staff but need additional team members to manage changes due to the COVID-19 pandemic.
  - Among those dentists, 75% indicated that they need additional team members because their practice procedures now require more staff than previously and 11.5% indicated their practice has implemented teledentistry technology.

## **Greater St. Louis Resolution**

- ▶ In an effort to address the current dental hygiene shortage, the MDA LRC be directed to work on legislation to:
  - 1. Increase funding for current dental hygiene programs;
  - 2. Increase the number of overall dental hygiene programs in the state of Missouri;
  - 3. Increase the number of graduates from the current programs, possibly by encouraging programs to hold night and weekend classes to meet the needs of the community; and,
  - 4. Encourage dentists in the community to become part of the faculty of these institutions to address shortages of educators.


# RDH Delegation to a DA

- ► Supervision Level for a Trained Assistant to Work under a Hygienist
  - 54% Support Rules to define a level of supervision for hygienists that would allow a trained dental assistant to work under a dental hygienist.
  - 66-79% Support For specific procedures under this level of supervision.

## **MDA Workforce Position States**

- ► The following procedures could be delegated to someone other than a dentist or hygienist (with proper training and supervision).
  - Placement and finishing all classes of restorations under direct supervision.
  - Removal of hard deposits.
  - Provision of palliative treatment via hand instrumentation only and placement of temporary restoration.
  - Administration of nitrous oxide by a hygienist under general supervision.


## How supportive would you be of rules to define a level of supervision for RDH that would allow a trained dental assistant to work under a RDH to perform the following procedures?




## RDH Scope

- ▶ Dentists were asked about support for allowing RDH:
  - To place an Interim Therapeutic Restoration (ITR) on a patient's teeth under general supervision of a dentist, after treatment planning by a dentist.
  - To administer certain types of **anesthesiological procedures** under *general supervision* of a dentist (with proper certification as defined by the Dental Board).

## **Current National Trends**

- ► The following states allow RDH to administer local anesthesia under general supervision:
  - Alaska, Arizona, Colorado, Idaho, Minnesota, Montana,
     Nevada, New Mexico, Oregon, Washington source, ADHA

Note: Each of these states has its own nuances within its practice act. Of these, Colorado is the only state that does not already have a dental therapy law.

## **Current Related MDA Policy**


- ► House Resolution 2013H-14 (Adopted)
  - The MDA shall take the position that only a dentist can diagnose conditions and manage complications that occur in and as a result of the practice of dentistry
  - The MDA policy is "the administration of local anesthesia by a hygienist shall be allowed only under indirect or direct supervision of a dentist."

## EFDA Scope


#### ► EFDA Periodontal Curriculum

- 61% Support For an expansion of the EFDA program to include a periodontal curriculum and permit under direct supervision of a dentist.
  - Of these, most dentists would support an educational format for an EFDA periodontal curriculum similar to current EFDA programs.






#### Would you support an educational format for an EFDA periodontal curriculum similar to the current EFDA programs?
